# <u>Job Purpose</u>

- The post holder will be providing evidenced based low intensity interventions to Children Looked after and Care Leavers with emerging mental health problems, primarily anxiety, low mood and deliberate self-harm.
- The post holder will be responsible for providing and coordinating support and advice to foster carers and staff via individual and group activities.
- The post holder will support Swindon Borough Council's SDQ and CRIES 8 Panel and be a key link with the Great Western Hospital, CAMHS, GP's, Schools, Children and Family Service and other key organisations in the public and voluntary sector.

### Key Accountabilities

- To assess risk and advise on appropriate referrals to CAMHS in Swindon and out of borough.
- To direct children and their carers, to the most appropriate service and support in order to meet their emotional needs.
- To offer a variety of specialist brief evidenced based and low intensity therapeutic interventions to children and young people.
- To provide formal and informal training and education to all agencies involved with the emotional health of Children looked after and Care leavers.
- To evaluate the outcomes for children and work in partnership with colleagues to ensure effectiveness.

### **Supplementary Accountabilities**

- To promote equality as an integral part of the role and to treat everyone with fairness and dignity.
- To recognise health and safety is a responsibility of every employee, to take reasonable care of self and

others and to comply with the SBC Health and Safety policy and any service-specific procedures/rules that apply to this role.

The role is flexible and the list of main tasks and responsibilities is not exhaustive.

# Knowledge & Experience

Candidates must have substantial knowledge and experience in the following areas of business and will be required to provide evidence of this:

# Essential:

- Specialist knowledge of child and adolescent mental health.
- Knowledge and understanding of NICE guidance around evidenced based practice in mental health.
- Demonstrate knowledge and skills to safeguard and protect children and young people's welfare.
- Able to recognise and assess children and young people with a wide range of clinical and behavioural presentations.
- Able to deliver effective evidenced based interventions to Children Looked after and Care Leavers.
- Able to develop and deliver psycho-educational workshops to Children Looked after, Care Leavers, families and other professionals where appropriate.
- Knowledge of the specific needs of children looked after and care leavers regarding mental health and emotional wellbeing.
- Able to use Microsoft Office (word and excel) to an intermediate level (e.g. able to use most of the systems functions without assistance).
- Good organisation and prioritisation skills
- Ability to work under pressure and to deadlines.
- Tact, diplomacy, confidentiality and sensitivity.
- Friendly and approachable manner with service users and other professionals.
- Driven, self-motivated and seeking opportunity to be part of and grow within a new and innovative approach to supporting children and young people's emotional health.

### Desirable:

- Knowledge of solution focused problem solving, cognitive behavioural techniques and/or psychodynamically informed practice.
- Understanding of restorative practices, resilience and strength building approaches.
- Knowledge of effective tools for analysing outcome measures.
- Knowledge of public, private and voluntary emotional health services
- Knowledge of legislation for Children looked after and Care leavers

# **Qualifications**

- Masters level qualification or equivalent experience and postgraduate training in a relevant mental health therapeutic and accredited area.
- Registered with an approved professional body e.g. Health and Care Professionals Council, British Association of Child Psychotherapists or Nursing and Midwifery Council.
- Other approved continued professional development and training relevant to mental health assessment and intervention (e.g. CYP IAPT).

### **Decision Making**

• In partnership with the children's teams, the fostering teams and other key agencies contribute to care planning including treatment plans, placement matching, transitions and support and safety plans.

### **Creativity and Innovation**

• Contribute to the further development of the Children Looked after Health Team.
