**Job Purpose**

To provide health based occupational therapy to a caseload of children and young people in school, clinic and home settings as part of wider packages of care to support children and young people to participate fully in their family, school and community. Work as a part of the integrated paediatric therapy team supporting the delivery of the service.

**Key Accountabilities**

- Skills for assessing & interpreting patient /client conditions, appropriate diagnosis, develop and implement OT programmes, providing advice to clients/ carers and other disciplines.
- To use assessment skills to identify and prescribe equipment to meet the needs of the individual child or young person.
- To demonstrate Communication & Relationship Skills, Provide and receive complex, sensitive diagnostic & prognostic information to patients/ clients, carers & relatives : to be able to sensitively take a case history, recognise barriers to communication and capture Children and young people voice.
- To demonstrate Planning & Organisational Skills: Plans & prioritises own & section patient workload, training sessions; plans and organises specialist service.
- To provide a high quality and an effective paediatric occupational therapy interventions for children attending special or mainstream schools, at home, in school or in clinic settings.
- Develops & implements occupational therapy programmes within a specialist field e.g. trauma, rehabilitation, mental health.
- Proposes and implements policy in own area of practice.
- As a member of the paediatric therapy team, to work as part of the multidisciplinary team, to work as part of the team recognising the individual roles of the other team members and working in partnership with them
- Allocates work to team members; supervises students/ provides training in specialist area
- Autonomous practitioner, works within codes of practice, guidelines/ may be lead specialist, may lead team, will be responsible for a caseload in the community.

- Participates in clinical audits; researches / tests different types of aids.
- To be responsible for the safe use of equipment.
- To work within your competency, professional code and guidelines.

### **Supplementary Accountabilities**

- To complete the relevant department 'competency' standards.
- To follow policies relevant to their role.
- To maintain all records in accordance with SBC policy.
- To supervise, train, advice assistants, student physiotherapists and occupational therapists.
- To participate in the SBC staff appraisal scheme as an appraisee and be responsible for complying with agreed personal development plans.
- To participate in elements of the measurement and evaluation of your work and current practices through the use of evidence-based practice projects, audit and outcome measures.
- To participate in identified work, contributing to improvements to service delivery and clinical practice.
- To engage in your personal and professional development, taking an active role in your learning in current knowledge of evidence-based practice in the areas of Paediatrics, developing specialist knowledge of particular conditions and patient types.
- To be responsible for maintaining a professional development portfolio showing evidence of own competency to practice through all CPD activities.
- To participate in safeguarding activities, training and support as required.
- To participate in the assessment and provision of SEN support to children and young people as required.
