Job Purpose

- To work as part of the safeguarding team, to be a source of advice and expertise on all safeguarding children matters to all children's community health staff.
- To demonstrate a high level of expertise in relation to the safeguarding of children and promote the wellbeing of children and respond in line with Working Together (2018) in order to put the child at the centre of safeguarding.
- To work to support practitioners to deliver a service which improves outcomes for vulnerable children and families, including those involved in domestic abuse and court procedures as required.
- To rotate as part of the safeguarding team in the Swindon multi agency safeguarding hub as the lead health representative, linking the different areas of health with the MASH. These are: Mental Health, Primary Care, Acute Care, Community Care services.
- To promote the use of timely, robust and consistent risk assessment of information gathered and shared across the agencies involved which will enable the proportionate, necessary and lawful disclosure of information at the earliest opportunity.
- To participate in strategy discussions and contribute to safeguarding decision making.

Key Accountabilities

- To contribute to the provision of supervision, training and audits and the ongoing development of clinical standards of care and research including the development of policies, procedures and guidelines in relation to safeguarding children, and any other work streams relevant to the protection of children
- Develop and maintain relationships with a broad range of internal and external stakeholders. Specifically health professionals from a wide range of services and disciplines
- Role model, promoting good practice and effective communication between all agencies, sharing proportionate information in accordance with GDPR (2018)
- To provide professional challenge as necessary to ensure the child is kept the focus of any safeguarding work and to support the use of the escalation process as required

- Working with the safeguarding team to ensure that new national and local guidance, policies and procedures are disseminated
- To ensure that new policies and procedures are developed in accordance with new legislation, statutory guidance and recommendations from serious case reviews.
- To work with professional leads in developing high standards of practice in relation to the management of vulnerable children and their families.
- To provide high quality supervision to staff in order to maintain and improve quality of services provided to vulnerable children and their families.

Multi Agency Safeguarding Hub

- Screening and Triage of all referrals from health practitioners from across the health workforce in Swindon to ensure the correct Swindon SSP thresholds are being applied
- To monitor and feedback to service leads the performance and practice of health practitioners in Swindon and ensure that their safeguarding practices are linked to referring to MASH when necessary
- To organise and collate the information gathering exercise linked to referrals to ensure a full and rich source of information to inform the decision making process
- To provide a summary and recommendation for the next course of action within the joint decision making forum using the agreed processes and procedures
- To disseminate the MASH outcomes for specific children to all relevant health practitioners including the referrer
- To ensure that the agreed Quality Assurance programme is delivered for MASH work by completing audits and reviewing outcomes on selected cases and collaborating with colleagues in MASH to ensure a whole systems approach takes place
- To represent health at the MASH operational meetings and to work as part of a co-located team of professionals to deliver an integrated service with the aim to research , interpret and determine what is proportionate and relevant to share
- Work collaboratively with the workforce leads in health services to ensure that early intervention and prevention are prioritised rather than a focus on referral escalation
