Service Manager – Attendance and Inclusion

Job Purpose:

To act as the authorised representative of the Local Authority To work with all schools in their area to remove area-wide barriers to attendance

To offer strategic advice, support and challenge to enable schools to develop improved systems and practice for managing attendance.

To undertake individual casework, as appropriate, with parents and pupils and address issues arising from non-attendance at school by working in partnership with schools, parents, children and young people and other agencies.

To be the responsible officer for the discharge of the Local Authority's duties concerning school attendance and the welfare of children under Section 444 of the Education Act 1996; section 36 of the 1989 Children Act and the Anti-Social Behaviour Act 2003

To comply with government guidance Working Together to Improve School Attendance 2024

Key Accountabilities:

- 1. To maintain a high level of knowledge about attendance issues, including policy, law and best practice in order to provide advice, support and challenge to schools.
- 2. To initiate regular school meetings with Head teachers or their named representatives in line with statutory guidance to identify any barriers to school attendance which may inhibit a child from making the most of the educational opportunities available to them.
- 3. To collect and analyse data in order to support school governors and head teachers improve school attendance especially for children identifies as persistent or severely absent.
- 4. To undertake casework to improve individual pupil attendance, typically on a commissioned basis All EWO casework will involve the setting of targets for improvement and will be time-limited and subject to regular review.
- 5. To initiate legal action against parents under Section 4441 or 4441a of the Education Act 1996. To support

- preparation of evidence and court papers. To be the key witness in court as appropriate. To be the responsible officer in implementing subsequent court orders i.e. supervising officer for parenting orders and education supervision orders when required.
- 6. To provide advice and guidance attendance staff in schools who may be providing support to families experiencing social inclusion issues i.e. pastoral support programmes, re-integration meetings, governors' disciplinary panels and referral to alternative educational provision.
- 7. To develop and maintain a knowledge of Legislation and Education Welfare Procedures and Protocols in relation to the non-school attendance of children and young people.
- 8. To maintain confidential records of cases, participate in quality assurance procedures, collect, and collate statistical information.
- 9. To make appropriate referrals regarding safeguarding and child protection issues. To prepare reports and attend child protection conferences and to maintain the knowledge and skills to participate in core group assessments, decisions and ensuing case work as appropriate
- 10. Support schools and others to initiate Children Missing Education and Pupil Tracking protocols. To support the named officer for Elective Home Education by providing reports for families who choose to educate their children at home. To ensure that the school has followed the correct procedure before deregistering a pupil
- 11. To participate actively in training, supervision and team meetings.
- 12. To provide training to schools, practitioners and other partners on all aspects of school attendance
- 13. To participate in Truancy Watch Patrols, in partnership with Wiltshire Police.
- 14. To participate in the implementation of the Council's equal opportunities policy and to demonstrate a commitment to anti-discriminatory and anti-oppressive practice in the development of client services.

Supplementary Accountabilities:

- 1. To promote and enforce the by-laws relating to child employment and entertainment.
- 2. To take an active role in Education Welfare initiatives e.g: Training Workshops for school staff to support Government Policy.
- 3. To launch and promote publications, reward systems and competitions to improve school attendance.
- 4. In accordance with the provisions of the Health and Safety at Work etc. Act 1974 take reasonable care for the health and safety of yourself and of other persons who may be affected by your acts or omissions at work; and co-operate with the Council so far as is necessary to enable the Council to perform or comply with its duties under any statutory health and safety provisions.
- 5. Undertake any other duties that can be accommodated within the grading level of the post.
- 6. There will be some requirement to work outside of normal working hours, for which time off in lieu of payment will be taken.
- 7. The job involves regular travel in order to visit schools and families at home.
- 8. To promote, including by personal example, Swindon Borough Council's commitment to welcoming and valuing diversity and ensure that no one will receive less favourable treatment or unjustifiable discrimination on the grounds of sex, sexuality, sexual orientation, marital status, disability, age, religion,

race, colour, nationality, ethnic or national origin.

9. To safeguard and promote the welfare of children young people under the Children Act 2004.
